

CITY OF NEW SMYRNA BEACH ANNUAL BOAT RAMP PERMIT APPLICATION FOR NON-COMPUTER APPLICANTS

*****NOTE: IF YOU HAVE A CURRENT NEW SMYRNA BEACH PARKING PERMIT FOR YOUR VEHICLE AS A RESIDENT OF VOLUSIA COUNTY, YOU DO NOT NEED A SEPARATE BOAT RAMP PERMIT TO PARK AT ONE OF THE THREE CITY BOAT RAMPS. YOU MAY NOT LEAVE YOUR TRAILER PARKED WITHOUT THE VEHICLE.**

**** For FIND DISTRICT Residents** applying for a FREE BOAT RAMP ANNUAL PERMIT the documents ALWAYS required are a current registration(S) for YOUR VEHICLE along with a VALID DRIVER'S LICENSE with a matching address within the District.

ADDITIONALLY, if the documents DO NOT have matching addresses in the District, you must provide one of the following:

- *Real Estate Tax Bill demonstrating that you own residential property in the FIND district
- *A copy of a residential property lease demonstrating a minimum of 6 months lease in FIND District
- *Copies of 4 consecutive utility bills for a residential property in FIND District

**** For Non-Residents** applying for a NSB ANNUAL BOAT RAMP PARKING PERMIT, the documents required are a current driver's license and a current vehicle registration. A \$200 fee is required.

GENERAL INSTRUCTIONS AND RULES FOR CITY OF NEW SMYRNA BEACH BOAT RAMP PARKING PERMIT

*****Boat Ramp Parking permits applications are accepted online at www.cityofnsb.com. Please include your email address clearly so we may notify you when your pass is activated. Failure to obtain a Boat Ramp Parking Permit or to abide by the parking rules may result in a citation. Individuals must pay \$10 per day to park at the boat ramps listed below if a pass is not obtained. Non-FIND District annual passes are also available to purchase for \$200/year.**

1. RESIDENTS OF FLORIDA FIND DISTRICTS MAY APPLY FOR A **FREE** BOAT RAMP PARKING PERMIT FOR THE FOLLOWING LOCATIONS:

NORTH CAUSEWAY BOAT RAMP - WEST SIDE

NORTH CAUSEWAY BOAT RAMP - EAST SIDE

SWOOPE BOAT RAMP (US 1)

2. FIND COUNTIES ELIGIBLE TO APPLY FOR FREE BOAT RAMP PARKING ARE:

3. PASSES ARE ELECTRONIC - YOU WILL NOT RECEIVE A PAPER PASS. THE SYSTEM OPERATES WITH YOUR TAG NUMBER; THEREFORE YOU MUST UPDATE YOUR INFORMATION IF THERE ARE ANY CHANGES ! IF YOUR TAG NUMBER IS INCORRECT AND YOU RECEIVE A CITATION, IT WILL NOT BE WAIVED.

4. PARKING AT THE BOAT RAMPS IS ENFORCED 24 HOURS A DAY - SEVEN DAYS A WEEK.

5. THE PARKING PERMIT IS AN ANNUAL PASS AND EXPIRES ON DECEMBER 31st OF EACH YEAR. YOU MUST RENEW YOUR PERMIT EACH YEAR.

6. VEHICLES WITH A VALID DISABLED PARKING PERMIT ARE NOT CHARGED TO PARK AND DO NOT NEED A NEW SMYRNA BEACH PERMIT.

7. AT THE PRESENT TIME, IF YOU HAVE A CURRENT NEW SMYRNA BEACH PARKING LOT PERMIT, YOU ARE **NOT** REQUIRED TO OBTAIN AN ADDITIONAL PERMIT FOR YOUR VEHICLE TO PARK AT THE BOAT RAMP. YOU MUST BE DRIVING THE PERMITTED VEHICLE.

8. YOU **DO NOT HAVE A PARKING PERMIT** UNTIL YOU ARE NOTIFIED VIA EMAIL THAT IT HAS BEEN ACTIVATED. THIS MAY TAKE UP TO FIVE (5) BUSINESS DAYS.

9. IF YOU DO NOT APPLY ONLINE, BOAT RAMP PARKING PERMIT APPLICATIONS & THE REQUIRED DOCUMENTATION ARE TO BE HAND-DELIVERED TO:

10. A BOAT RAMP PARKING PERMIT **DOES NOT APPLY TO ANY OF THE CITY BEACH PARKING LOTS !! YOU MUST HAVE A CITY OF NEW SMYRNA BEACH "BEACH LOT" PERMIT, AN ANNUAL NON-RESIDENT PERMIT, OR PAY \$20 TO PARK IN ONE OF THE BEACH LOTS.**
